On behalf of the San Mateo County Transit District, I am writing to personally thank you for submitting the SamTrans South Base Battery Electric Bus Charging Infrastructure Project for funding consideration as part of the FY2022 Transportation, Housing and Urban Development Appropriations Bill.

This funding will be instrumental as we work to design and construct battery electric bus (BEB) charging infrastructure at the SamTrans South Bus Base in San Carlos, California, addressing the need to support an all zero-emission fleet by 2038 - a goal adopted by the SamTrans Board of Directors.

SamTrans plans to first use this infrastructure to launch a zero-emission limited stop/express route connecting East Palo Alto, major employers along the US-101 corridor, SFO and BART at the San Bruno Station.
