• Existing Litigation: Audrey Stout v. San Mateo County Transit District

She said that the Board had approved the final settlement in the amount of \$130,000.

• General Manager Performance Evaluation and Conference with Labor Negotiator

She said that the Board was ready to consider a resolution approving the Third Amendment to Jim Hartnett's Employment Agreement, which includes a 3 percent adjustment to his base salary, bringing his total base salary to a total of \$289,483. She said the 3 percent increase is retroactive to April 1, 2018, the time at which the Board concluded Mr. Hartnett's evaluation and determined that he was entitled to that amount. She said the Board has also approved within the confines of his Employment Agreement – recognizing that he met and surpassed all his goals for the year 2017 through 2018 – performance pay in the amount of \$50,000.

Chair Stone thanked Mr. Hartnett for deferring his salary increase the previous year.
