- ## Proposal: Fixed Route *continued*

- Youth age: Expanded from 17 to 18 years
 - Child: 2 free with fare-paying adult, increased from 1
 - Way2Go Pass: Increased from \$125 to \$130 in 2019, with minimum participation rate of \$13,000
